## Remembering When Citrus Was King! Co-Dependency Of Railroad & Citrus Industries Recognized



On 10-28 our Visitor Center was struck by a pick-up truck in an attempt by one man to run over another man. Besides \$900+ in damages to our roll-up door, untold damage was caused to Jerry Mathews' pre-1960 Lionel train layout — a main attraction of the Center. Repairs to both are pending.

#### **FRA Requires Training For Switchmen**

Following a series of railroad industry accidents involving improperly aligned switches in non-signaled territory, the Federal Railroad Administration (FRA) has issued an Emergency Order Authority mandating training for affected employees. The FRA said order E024 is necessary to ensure that railroad employees who dispatch or operate hand-operated main track switches in non-signaled territory return the switches to normal position after use. Under the Emergency Order:

- No employee is permitted to operate or verify the position of a hand-operated main track switch in non-signaled territory unless qualified on EO24 and the railroad's operating rules.
- A written receipt or acknowledgment that each employee has received training must be obtained.
- Employees operating hand-operated main track switches in non-signaled territory must complete a switch position awareness form, conduct job briefings and communicate with the engineer by radio.
- Affected employees must receive a copy of EO24. Though they do not need to carry it, employees will be asked by FRA inspectors if they have received it, and have been trained and understand it.

The training must be implemented no later than Nov. 22, 2005. Violations can result in civil penalties of up to \$27,000 for individual <u>employ-</u> <u>ees, managers</u> and <u>company</u> for any violations. by Rick Swanson, President

The growth and history of the Santa Clara River Valley rests primarily on two industries – oil and citrus. And the railroad made them both possible! Express reefer, one of many that traversed the valley rails hauling fresh oranges and lemons to eastern markets. Several of our members, and even a past society president, are citrus ranchers in the valley with rich family histories to draw upon. Our Railroad Visitor Center is located just a few blocks from historic citrus packing houses and the outlying areas between Piru and Ventura are filled with citrus groves and fruit stands.



Heck, Fillmore even has an annual Orange Festival. It's a natural idea!

Our current Railroad Visitor Center is the temporary home of what will be the Exhibit Center or phase 3 of our Railroad Interpretive Center (RIC) project (the turntable being phase 1 and the roundhouse phase 2). The exterior of the Exhibit Cen-



ter can be designed to look like an old packing house. Inside we will have a section of track from the roundhouse that can be used to display the PFE car and perhaps an overhead ice loading platform and loading dock similar to that currently on display in the State Railroad Museum in Sacramento. Related farming and railroad tools can be displayed as well as packing boxes and labels. We can tell the

story of how fruit got to market (by railroad of course). The Citrus theme can be to the Exhibit Center what railroading is to the turntable and roundhouse – one big real life co-dependent operation.

So as members, if you think this has potential, let us know. In the meantime, feel free to start searching for those old packing box labels from the Santa Clara Valley when you go antiquing. Look for old photos of trains and citrus operations too (Oxnard had a PFE icing facility until the late 1970's). Collect stories and document historically related events. Search the attic and the barn for related display materials. Let's begin to transform the current Visitor Center and get a head start on our future!
